TERMS AND CONDITIONS

EDHE Student Entrepreneurship Week (SEW) 2022

Student Design Competition

Submission

Student creatives and graphic designers may either submit individually or as a team, specific to the competition but must be a registered student at any South African public university. Competition entrants are prohibited from sale, assignment or transfer of any of their submission rights to a third party. Once the final submissions are sent, EDHE does not allow additional changes to the designs.

Competition Disqualification

The Entrepreneurship Development in Higher Education (EDHE) holds the right to disqualify any submission which is non-compliant with the design brief and does not meet the terms and conditions. Submissions after the closing date shall be automatically disqualified. EDHE shall be under no obligation to notify the entrant or participant of the disqualified entry or submission.

Competition Cancellation / Withdrawal

The right to cancel or suspend or alter the rules of the competition at any point in time is held by EDHE, if deemed necessary in its opinion and if circumstances arise outside its control.

Competition Integrity

The judging panel will be determined by EDHE, with the sole right of the final decision to do so rests with the EDHE.

Winner Selection

EDHE is determined that the winning design, through its panel of judging members, will be final. If under any circumstances a selected winning entry cannot accept, receive or is ineligible for the award for any reason, the highest ranked entry from the top shortlisted or remaining entries that meet the winning requirement shall be deemed the winner.

Organisation and Administration

The Student Design Competition is organised and administered by Entrepreneurship Development in Higher Education (EDHE). EDHE holds the right to assign any juries, agents or other authorised administrators to administer its competitions, including making any decision or exercising such at its discretion.

Awards and Prizes

The awards and prizes shall be advertised with the competition, however, the right to withhold, add, alter or introduce additional awards and prizes will be held by EDHE.

Students will be required to submit proof of their student status for the competition, should the submission be selected as one of the winning entries. Failure in doing so shall result in disqualification and lead to forfeit.

In the case of monetary awards, all bank account details into which the prize money is to be paid must match with that of the registered individual or team leader or studio or the company. A bank confirmation letter will be required. All local taxes on the value of the prize are the sole responsibility of the winner.

If the winner chooses not to accept the prize, an alternate winner will be chosen. If the winner fails to return any award or prize notification requested within fourteen days of the attempted first notification may result in disqualification and the prize will be forfeited.

Ownership and Copyright

The ownership and intellectual property for the top three designs will belong to EDHE.

Participants shall not receive or be entitled to receive any payment for participating in the competition and for granting EDHE any right herein, other than for being selected as one of the winning entries of the competition.

The competition participants agree to share their entries for making publication based on competition results by entering the EDHE Student Design Competition. Participants are solely responsible for protecting the intellectual property of any submission to EDHE.

Plagiarism

If charges of plagiarism are made against any participant, the charges are to be addressed at the earliest by the accused participant. EDHE holds the right to take down the content from all its channels until the matter is resolved.

Publicity

By entering the competition, the participants acknowledge and accept that all assets submitted such as designs description, details, images, illustrations and animation may be used for publicity purposes by EDHE.

Winners agree to, and shall upon request at reasonable notice, participate in publicity or promotional activity around the competition, such as interviews. Each opportunity shall be taken on merit, and each participant shall have the right to decline any such opportunity.

Publication

EDHE holds the right to publish such material in whole or in part, or use them in any way it sees fit in connection with the EDHE website or its competition without the permission of the participant.

Privacy Policy

EDHE is aware of your privacy and its importance. Any information collected on our site is used only for processing and administration of your competition entry according to the competition brief, and terms and conditions and optimise your visit to our site from your personal experience.
